Our services are rendered to people of all ages from infants to the elderly and everyone in between.

Our School Supply program provides supplies to children preschool - 12th grade whose families financially qualify. The Student United Engage Leadership program provides 9th grade students in our service area the opportunity to develop leadership and character through a variety of community awareness and service projects. The Student United Leadership Exploration and Development program (LEAD) provides 10th, 11th and 12th grade students who work year-round to raise funds to benefit other local teenagers in need. Pre-K through 12th-grade students in Norman, Noble, Little Axe, Lexington, and Robin Hill can apply to receive school supplies collected during Stuff the Bus. We use federal income guidelines to determine who can receive free school supplies. Families will need information on all sources of income to complete the sign-up form. or by the Board of Directors. This committee shall report its activities at
each regular meeting of the Board of Directors.
